1	INTRODUCTION Course requirements; forming groups; QA
2	PROJECT INTEGRATION MANAGEMENT Discusses the process plan development: strategic planning in long terms, types of plans, project management planning and its linkage to failure, schedule development. Explains strategic planning and project plan execution: the execution of the project plan by performing the activities included therein, coordinating changes
3	PROJECT COST MANAGEMENT Explains the processes required to ensure that the project is completed within the approved budget. This includes cost estimating (i.e. developing an estimation of the cost of the resources needed), cost budgeting (i.e. allocating cost estimation to each work item), and cost control (i.e. controlling changes to the project budget)

4	PROJECT HUMAN RESOURCE MANAGEMENT Discusses the use of human resource efficiently and effectively which includes staff acquisition (i.e. getting the appropriate human resources) and team development (i.e. developing individual and group skill to increase project performance)
5	PROJECT MANAGEMENT IN AN INTERNATIONAL CONTEXT This session emphasizes the issues regarding a project management context across cultures and countries. In addition, it also explains the importance of international scene and aligning business, emerging technologies as well as their influences on the project management includes
6	PROJECT EXECUTION Explains team development, procure outside resources, quality control (i.e. monitoring specific project results to determine if the results meet the quality standard), information distribution.
